The movement restrictions or national lockdowns enforced in many countries to curb the spread of the virus transmission have affected the clinical practices of spine surgeons globally. Our APSS Research Committee had taken an effort to investigate the impact of the COVID-19 pandemic on the clinical and surgical practices of spine surgeons in the Asia Pacific region. This study had been published in the Spine Journal recently. The findings from the study indicated that 92.3% of a total number of 222 respondents from 19 countries felt that their clinical practice had been affected (for further details, kindly read the summary of the publication on pages 4 and 5). On a similar note, we are honoured to have an esteemed APSS Board Member from Hong Kong, Dr. Yat-Wa Wong, to share his clinical experience in the management of orthopaedic patients in Queen Mary Hospital amidst the COVID-19 outbreak in Hong Kong in this newsletter.

APSS EXCO members have also leveraged on the downtime to finalise the APSS Organisational Chart. Under the governance of the Board and Management of the EXCO, six Committees were formed to look at different aspects of the Society: (1) Finance; (2) Governance; (3) Community Development; (4) Education; (5) Congress; and (6) Research Committees. The Constitution, Bylaws and Procedure and Policy Menu (PP&M) Sub-Committee under the purview of the Governance Committee has been mandated with the task of drafting the detailed operation procedures of the Society. We look forward to share the complete draft soon.

We are pleased to inform the successful incorporation of the Asia Pacific Spine Society Limited in Hong Kong. The APSS Limited is currently in the process of applying for tax exemption status as a non-profit corporation. Board Member's Message



As the Honorary Treasurer, I witness how APSS becomes financially independent of APOA. To accomplish the task, it is not simply taking back all our savings and depositing them into our bank account. Dato Dr K S Sivananthan has made tremendous effort to collaborate and negotiate with APOA to repatriate all of our money to be deposited in our bank account. The next hurdle is where the assets are safely stored. Because of concerns about money laundering, the difficulty of opening a new bank account is beyond my imagination. APSS must first be registered as an official association or company. We chose Hong Kong for registration because of its low tax rate and the ease of sending money in and out of the territory. The second obstacle is finding a bank that trusts APSS. With the joint

efforts of EXCO members, good track record in APSS and the assistance of our audit firm, we finally have our own bank account. Our next goal is to obtain tax exemption in HK. By the end of 2021, we will produce our own audit reports to ensure that every dollar we earn or spend is appropriate, legal and transparent.

Our financial administration is now independent, but we are not truly financially independent. Our current asset is about half million US dollars. However, we need about US\$50,000 per year to maintain the baseline operations, such as purchasing secretariat services. My wish is to expand our savings to the point where only interest income can maintain the basic operations. This is why I emphasised so strictly that there is a slight positive balance with most APSS activities.

Dr Yat Wa Wong also shared with us his personal experiences on the management of spine patients in his hospital during the COVID-19 outbreak in Hong Kong.

I am currently the Deputy Hospital Chief Executive and Chief of Service of the Department of Orthopaedics and Traumatology. In the face of the recent COVID-19, many medical and nursing staffs have been under tremendous pressure and have experienced increased burden on patients' management. The guiding principle of handling the crisis is to support the entire hospital and Hong Kong in fighting the war while taking care of colleagues' emotion.

In the early stages of the COVID-19 attack, infection control training and education were organised to alleviate their fear and anxiety in handling COVID-19 cases. Most colleagues do not forget the main goals of health care workers. They voluntarily provide services to COVID-19 patients. Our department has deployed the most personnel to the isolation wards. It will inevitably lead to a shortage of manpower. The remaining colleagues worked hard to get through the tough times. We maintained basic services such as trauma, oncology and emergency surgery, but appropriately reduced other elective tasks.

In addition, we transferred postoperative cases to surrounding supporting hospitals or discharged them as soon as possible after the condition permitted. Rehabilitation is always necessary, but it can be done at home or on an outpatient basis. Telemedicine is another mean to strengthen supervision and monitoring of patients' progress. The disaster will eventually pass, but I am proud of the selfless dedication of my colleagues to take care of various patients.

The Impact of COVID-19 pandemic on Spine Surgeons: An Asia Pacific Spine Society (APSS) Survey

Background

COVID-19 is an infectious disease caused by the SARS-CoV-2 virus. It was first identified in December 2019. This infection caused symptoms that ranged from mild cough, sore throat, and fever to severe viral pneumonia with multiple organ failure. To date, over 18.6 million people were infected worldwide with 1.73 million death recorded. Movement restriction or national lockdown was enforced in many countries to curb the progression of the virus transmission. The disease itself coupled with these measures had led to a profound worldwide social and economic impact. This study was conducted to report and investigate the impact of COVID-19 pandemic on the clinical practices of spine surgeons within the Asia Pacific region.

Methods

This is a cross-sectional survey that was carried out from May 4, 2020 to June 4, 2020. The questionnaire was administered using REDCAP. The online questionnaire was divided into four sections. First section were questions on the surgeon's demographics, background, type of clinical practice, and status of pandemic in their country. Second section included questions on the volume and the type of spine surgery practice before the COVID pandemic. Third section included question on the changes of clinical practice during the pandemic and the last section was regarding their concern on COVID transmission.




Figure 1. Survey respondents according to country. 222 respondents completed the survey.

Findings

Total of 222 respondents from 19 countries completed the questionnaire. During the pandemic, 92.3% of the respondents felt their clinical practice was affected. 58.5% respondents reported reduced outpatient clinic hours and 74.6% respondents reported reduced operation theatre hours due to the enforcement by the hospital administration. The mean reduction of clinic volume for all countries was 48.1%. There was a significant reduction in the number of surgeries performed in Japan, Malaysia, India, Philippines, and South Korea. This was due to reduced patient load. More than 60% of respondents were worried being infected by COVID-19 virus and >68% were worried of transmission to their family members.




Figure 2: Reduction in outpatient clinic volume in Asia Pacific countries

Conclusion

COVID-19 pandemic had significantly affected the clinical and surgical practice of spine surgeons in the Asia Pacific region. Clinics were closed or the practice hours were reduced. Similarly, surgical theaters were closed, reduced, or limited to semi-emergency and emergency surgeries. Spine surgeons were moderately concerned of contracting COVID-19 during their clinical practice but were extremely concerned to transmit this disease to their family members.
